### **Companion Animals - USDA Rural Development**

- A companion animal, unlike an assistive animal, is one with no special training in helping an individual cope with a disability
- Companion animals are used for company, amusement, psychological support, extrovert display and all of the other functions that humans need to share with animals of other species

### **Animal Protection Laws of Guam**

### **THE PREVENTING ANIMAL CRUELTY AND TORTURE (PACT) ACT**

- The purpose of the PACT Act is to strengthen the 2010 law that makes the depiction of animal cruelty a crime, but allows the cruelty itself to go unpunished
- The PACT Act would make it a federal crime for “any person to intentionally engage in animal crushing if the animals or animal crushing is in, substantially
